



Third College-wise Selection List for Admission in Private Sector Medical Colleges of Punjab against Open Merit & Overseas Quota Session 2025-2026

January 08, 2026

IMPORTANT NOTE

1. The Third (College-Wise) Selection List for admission to Private Sector Medical Colleges in Punjab against Open Merit and Overseas quota has been prepared based on the seats vacated by candidates who failed to join their respective colleges within the prescribed timeframe after the display of the Second Selection List on January 01, 2026. This selection process has been carried out strictly in accordance with the Procedure and Conditions of Admission Policy notified by the Specialized Healthcare and Medical Education (SHC&ME) Department, Government of the Punjab, vide Notification No. SO(ME-II)2-1/2025.
2. The **newly selected candidate(s) from the waiting** are required to complete the following mandatory steps to confirm admission:
 - i. Log in to your existing account on the Admission Application Portal at <http://private-mbbs.uhs.edu.pk/> and generate the prescribed **fee challan of PKR 600,000 (Six Hundred Thousand).**
 - ii. Deposit the fee in the nearest branch of the Bank of Punjab (BOP) or National Bank of Pakistan (NBP), through branch banking or via the 1Bill invoice (top-up option may not be used) and upload the **paid challan/fee deposit slip** on the admission portal not later than **05:00 PM, 13th January, 2026**.
 - iii. All candidates are desired to strictly comply to the Section titled "*For private Sector Colleges*" clause (a) of the policy notified by SHC&ME department, reproduced below:
"Upon display of name in the merit list, candidates shall deposit Rs 600000(6 lacs only) within three (03) working days after display of the merit list in designated account of UHS, Lahore to secure admission seat offered. Failure to deposit Rs. 6 lacs/- only within stipulated time (three days after display of merit list) shall result in withdraw of admission offer and seat shall be offered to the next candidate in merit"
- iv. After uploading the paid receipt on the portal, select one of the following options, as notified under Section (8) titled "For Private Sector Colleges", Clause (c) of the policy of SHC&ME department:

"Candidates shall mark their Joining and give Consent for Up-gradation or Stay on the online portal of UHS. In the online Consent Form, candidates are required to indicate their choice from the following options:

- i. Retain their allocated seat in the same college; **OR***
- ii. Opt for up-gradation as per merit and order of preference in the subsequent selection list."*

A. UPGRADATION: Candidates may opt for "UPGRADATION", in accordance with their merit and order of preference in the subsequent selection list.

Only those candidates shall be considered admitted with the right for "UPGRADATION" who have;

- o Submitted the requisite online undertaking available on the portal
- o Paid the prescribed fee (PRK 600,000/-) and have uploaded the proof of same within prescribed deadline.
- o Such students are not required to join college in person.

B. First Preference Candidates (No Upgradation):

Candidates who have been allotted a seat on merit in their **first (top) preference** shall not be eligible for upgradation, as they are already placed in their highest choice. There is no provision for down gradation to a lower preference at any stage of the admission process. Consequently, candidates allotted their first preference are required to join the allotted college with the only option of **STAY** within the prescribed time by completing all mandatory steps in accordance with Clause (v) below, including payment of fees and submission of joining documents.

C. STAY: The candidates who wish to retain their allocated seat in the same college and do not want to opt for upgradation shall choose the "STAY" option:

The options for Stay or Upgradation once availed, shall attain finality and shall neither be revoked nor modified at any subsequent stage.

v. **Joining Requirement (Applicable to B & C):**

Candidates opting for "**STAY**" or those who have been allotted their **first preference** (as stated in **Clauses B and C**) shall be required to follow these mandatory steps:

- a. Download the Joining Report and Consent Forms from the portal.
- b. Complete the Joining Report and Consent Form.
- c. Visit the respective medical college where their name appears along with duly filled Joining Report Form, Consent Form & with proof of fee payment as at section 2 (ii).
- d. Get the Joining Report Form and Consent Form signed and stamped by the Principal/Focal Person of the respective college.

- e. Submit the prescribed remaining college fee (other than already paid PKR 600,000 at the designated account of UHS) in accordance with the current PM&DC Regulations for fee payment, no later than **05:00 PM, 13th January, 2026**. UHS shall directly transfer the already deposited amount (PKR 600,000) to the concerned college after closing of Admissions.
- f. Upload a clear scanned copy of the Joining Report Form and Consent Form, along with the proof of payment of the college fee (receipt/transaction proof), on the same portal in accordance with PM&DC Regulations, and also email the same documents to admissionsfee2026@uhs.edu.pk, before than **05:00 PM, 13th January, 2026**.
- g. Only those candidates who complete above actions will be considered as admitted to the program. Failure to comply with any of the above steps shall result in the cancellation of admission forthrightly, as notified in the policy issued by SHC&ME department under the section (8) named "For private Sector Colleges" clause (a) reproduced as below:

"Upon display of name in the merit list, candidates shall deposit Rs 600000(6 lacs only) within three (03) working days after display of the merit list in designated account of UHS, Lahore to secure admission seat offered. Failure to deposit Rs. 6 lacs/- only within stipulated time (three days after display of merit list) shall result in withdraw of admission offer and seat shall be offered to the next candidate in merit"

3. Previously Selected candidate(s) who have selected either "**STAY**" or "**UPGRADATION**" after the display of the Second college-wise Selection list displayed on (01-01-2026) are required to follow the following instruction:

- a. Candidate(s) who have successfully **joined** their allocated colleges against Open-Merit and Overseas quota seats as per the Second Selection List dated 01-01-2026 and have opted for "**STAY**" in the consent form and physically joined their respective colleges, shall remain in their previously allocated colleges. Such candidates are not required to take any further action, including no physical reporting to the college and no visit to the UHS admission portal.
- b. Candidate(s) who have not been upgraded to a higher preference as per merit shall also remain in their previously allocated colleges. These candidates are not required to pay the UHS admission fee of Rupees 600,000 again. However, they must log in to the UHS admission portal and select either "**STAY**" or "**UPGRADATION**".
 - If the candidate selects "**STAY**", they shall then be required to follow the procedure outlined in **Section iv (Points B and C) and Section v** as described above.

c. Candidate(s) who have been successfully upgraded to a higher preference college as per this merit list are not required to submit UHS admission fee of Rupees 600,000. However, they must log in to the UHS admission portal and select either "STAY" or "UPGRADATION".

- If the candidate selects "STAY", they shall then be required to follow the procedure outlined in **Section iv (Points B and C) and Section v** as described above.

4. Candidates selected on Multiple Categories (Open-Merit & Overseas Quota)

The candidates eligible for admission against two or more categories of seats shall be admitted on the seat where he/she is getting a better/higher college as per his/her own order of preference. The category of seat allocated shall be final and irreversible, rendering the other category as null and void.

5. Those who fail to complete any of the requirements as mentioned in serial no. 2, 3 & 4 within the due date shall be excluded from the admission/ upgradation process and shall have no right of admission/ upgradation into the said programme in the current session.
6. Errors & Omissions Excepted (E&OE): The Vice Chancellor, University of Health Sciences (UHS), Lahore, reserves the authority to review and amend the selection list in the event of any bona fide error, lapse, mistake, fraud, or misrepresentation that may be identified or brought to his attention before or after the completion of the selection process. The inclusion of a candidate's name in this selection list shall not confer any absolute right to admission if they are subsequently found ineligible due to any error, mistake, fraud, or misrepresentation.
